
#### **Beyond Korea to Asia**

# Advantages of obtaining ISO certification


ISO certification is an international standard for management systems as defined by the International Organization for Standardization (ISO), It is a system that certifies that the company's system meets the requirements and operates effectively.

ISO is an organization established to facilitate international exchange of goods and services and to promote standardization and related activities in terms of cooperative development in the fields of knowledge, science, technology and economic activity.

ISO certification is also helpful when you need to ask for a start-up fund from a commercial bank, the Small& Medium Business Corporation, Korea Technology Finance Corporation, the Trust Guarantee funds. In addition, ISO 9001 (Quality Management System) certification and ISO 14001 (Environment Management System) are additional points.

In the introduction stage, if you have been in business for more than 3 years after establishing a company, and you want to receive a management innovation SME (main biz certification), a technology innovation SME (Innobiz certification), etc, if you have a basic ISO certification, it will be added to the certification evaluation. For this reason, many companies maintain ISO certification through a follow-up surveillance audit every year after obtaining initial ISO certification.

In the maturity stage, there is a lot of government support available to companies with ISO certification, so ISO certified companies are given additional points in the assessment of the designation of excellent procurement. Eco-friendly points are granted to ISO 14001-certified companies. In the case of the Export-Import Bank of Korea, ISO-certified companies have benefits such as granting additional points when applying for special credit loans.

Gerfor is a Columbian multinational company serving the plastics and synthetic fibres sector of the petrochemical industry. Gerfor achieves savings of over 5 million dollars annually, with the use of 200 technical standards and ISO management systems.



Nanotron Technologies, a German information and communications technology company, achieved 14 % cost savings and 19 % increase in sales revenue by using standards, equivalent to almost 33 % of overall annual sales revenue.



The Lincoln Electric Company of Canada, a large multinational employing over 10,000 staff, has a Welding wire and manufacturing plant in Toronto, Ontario. Accredited certification enabled the company to saving 22% of its annual energy costs in 2013.



IBM has a global EMS, which is underpinned by ISO 14001. Between 1990 and 2014, IBM's conservation efforts avoided 6.8 million MWh of energy consumption and an associated 4.2 million metric tonnes of CO2 emissions. During 2014, IBM achieved energy conservation savings equal to 6.7 % of its total energy use.



Italy's Workers' Compensation Authority, INAIL, the national governmental institute for insurance against accidents at work, offers businesses up to 28% on the cost of insurance premiums for businesses who hold accredited certification to the Health and Safety management systems standard, OHSAS 18001.



#### 1. ISO 9001 certification system?

This is a standard on Quality Management established by the International Organization for Standardization (ISO), which is a requirement to be recognized internationally that an organization has the ability to meet requirements. It is a system that pursues long-term growth and development of the organization by securing a competitive advantage through overall quality improvement of the entire company, improving customer satisfaction and enhancing organizational competitiveness.

#### 2. ISO 14001 certification system?

ISO 14001 provides objective certification by evaluating the overall environmental management system of business activities, as opposed to the existing international environmental regulations, and evaluates how the company conducts comprehensive environmental management, including environmental policies, implementation and operation, inspection and corrective actions, management reviews, and continuous improvement, beyond simply compliance with the applicable environmental laws or regulations.

The Occupational Health and Safety Management System involves all employees and stakeholders in order to prevent industrial accidents and create a pleasant working environment. The health and safety management system establishes goals for maintaining and improving the safety and health of employees, and defines the organization, responsibilities and procedures for identifying and managing risk factors inherent in the organization's activities. It makes organization effectively allocate physical and human resources within an organization and manages them systematically.

Therefore, OHSAS 18001 certified companies must migrate their certification to ISO 45001. SPEC offers optimal certification services to help you migrate quickly and smoothly.

\*Joint certification of K-OHSMS 18001 and KOSHA 18001 In addition, SPEC has concluded into a joint certification agreement with the Korea Occupational Safety & Health Agency in the field of Occupational Health and Safety Management System in order to enhance the convenience of the workplace. We jointly issue certificates of both institutions together.

#### 4. ISO 22000 certification system?

ISO 22000 is an international standard that can be applied by all stakeholders in the food supply chain. It defines the principles of mutual communication, system management, Pre-Requisite Programs (PRPs) and HACCP, and is key elements to ensure food safety throughout the food supply chain. Based on the ISO 9001 Quality Management System, ISO 22000 includes all 7 principles and 12 procedures of HACCP. By integrating these two systems, organizations can achieve their goals of ensuring food safety and continually improving performance. ISO 22000 Food Safety Management System is an autonomous food safety management system that proactively prevents and manages food hazards that may arise at workplaces. Through the implementation of such food safety management systems, companies can meet the legal and consumer expectations and secure competitiveness for the continued growth of their organizations.

#### **♦**Necessity

Securing food safety emerged as an essential achievement for food-related organizations as a result of the recent emphasis on customer demand for food safety, and the introduction of a management system for food manufacturing and management has been widespread. Producers and suppliers in the food supply chain can be managed with food safety standards such as British Retail Consortium(BRC), EUREPGAP, and Good Manufacturing Practices (GMP) for HACCP food and food packaging, and ISO 22000, a Management System for food function and quality control.

The Anti-bribery Management System prevents increased business, product costs, and reduced service trust caused by corruption, and establishes a integrity, transparency, openness and compliance culture through this system. It is applicable to all organizations, from public institutions to private companies. The Anti-bribery Management System is a system that pursues the integrity of the organization and the voice of customers by achieving anti-corruption goals and policies through analyzing and managing corruption risks.

   The importance of Anti-Bribery efforts has been emphasized since the enactment of the Act on prohibition of Anti-Bribery and graft act(Kim Young-Ran Act).

#### 6. ISO 21001 certification system?

ISO 21001 is an international standard developed by the ISO(International Organization for Standardization), which provides management tools for organizations that provide educational products and services. It helping providers meet student demand and needs. ISO 21001 is based on the ISO 9001-Quality Management System, but provides a specific framework for educational institutions that aim to improve learner satisfaction by improving curriculum and complying with learner requirements.

This standard is applicable to any organization that offers a curriculum for developing knowledge, skills, and attitudes through a variety of teaching methods.

From kindergarten to university, vocational education and coaching, the world of learning is constantly changing and evolving. ISO 21001, Educational Institutions- Educational Organizations Management System- for Educational Institutions- instructions for Use are intended to address this challenge by defining the requirements of management systems that will help educational providers better meet the needs and expectations of learners and other beneficiaries. Will. Acquiring ISO 21001 certification can prove to stakeholders that we are working to improve our education system, showing greater trust and impact.




